Everybody needs help at some point in their lives and therefore the ethos of early help is an important focus for Linden Primary School. Early Help is all about children, young people and their families getting the right support at the right time, providing this support as soon as a problem emerges.

At Linden Primary school we have a dedicated team who are committed to safeguarding children and protecting their welfare. Our Inclusion Team works closely with the children of Linden and their families to ensure an holistic approach to every child's development.

We appreciate that every child has a different level of need and this level of need can be different at a range of times within their lives. Therefore it is important to consider the level of the child's and family's needs, to ensure that the right support and help is given. By examining the children's needs we can consider which professionals and Early Help Partners should be involved, to ensure that children are supported and safeguarded no matter what their level of need is. The table below identifies the level of need of the child and family and corresponding provision and services that would be appropriate to support these needs at that time.

Universal Children are making typical development academically and emotionally. Children and Families do not need support from Early Partnerships, apart from what is universally on offer.	<ul> <li>The Inclusion team: All our Inclusion Team are available to all families in a pastoral manner. Any family can contact the Inclusion Team with a concern. If the member of the team does not have the answer, they will sign post to a service that will. Our team consists of an Inclusion lead, who is also SENDCo, designated teacher, EAL lead, pastoral lead and attendance lead. In addition to this, we have a parent support advisor, attendance officer and a number of members of staff trained to provide different levels of pastoral support. We also have 4 members of the Inclusion Team who are DSL trained. All members of staff who are DSL trained are signed up to the GCSB's email alerts.</li> <li>Teaching and learning at Linden: Our Linden curriculum aims to develop all pupils so that they can become lifelong learners. All learning is based on quality first teaching that is tailored to the needs of the individual pupil. This supports all Linden children to develop social and emotional skills appropriate for their age.</li> <li>Home school partnership: At Linden, we work closely with the parents and families of the children so that communication is open and consistency between home and school can be achieved. We work together with families to ensure that together we are developing the child the best we can.</li> <li>Wrap around care: Linden offers a Breakfast and After School Club. This allows parents to be supported by school in regards to child care, but also allows the school to support parents in providing a healthy diet that supports learning, as well as support with completing homework and reading etc.</li> <li>E-safety- Children across the school are taught explicitly about safety online. This is embedded into the Linden Computing curriculum across the school, with additional focus upon this for Year 6 children. In addition to this Linden run training on E-safety for parents to attend in conjunction with our designated PSCO at the police.</li> <li>Staff Training: The Inclusion Team ensure that all staff have the up to date and relevant training to safeguard children and ensure their welfare. The team are guided by the advice from the GSCB.</li> </ul>	
Targeted Children or families may need some targeted support. This may be due to health or medical needs, as well as the academic or social and emotional development of the children.	<ul> <li>Please see all of above</li> <li>Class Teacher monitoring: Class Teachers monitor the children and families appearance, and engagement. They notify Inclusion Team of any changes in the child or families behaviour. Inclusion team to monitor these on the class diary form which is inputted on to CPOMs</li> <li>Designated Safe Guarding Lead: If after monitoring the class diaries on CPOM's the inclusion team are still concerned about a child's change in engagement and</li> </ul>	<ul> <li>Please see all of above</li> <li>School Nurse/GP/Health Visitor: Sometimes when the child has a medical or health need that needs more support from a professional, the school and parents can access this through the relevant avenues.</li> <li>Young carers: Some children need a special place they can attend where they can be themselves without their family. It gives them a place to talk and a place to do things they enjoy. The Inclusion team can make a referral to Young Carers for targeted children.</li> </ul>

	<ul> <li>behaviour, a member of the Inclusion Team who is DSL trained will discuss the changes with the parents/carers to see if there is an underlying issue that perhaps the school can support the family with.</li> <li>Attendance Officer: The Attendance team monitors children attendance, their reasons for absence and their punctuality. If there are concerns around a child's absence, attendance or lateness, the Attendance officer will meet with the parents/ carers. The Attendance Officer will aim to support families with attendance and punctuality as much as possible.</li> <li>Adult education: Linden Primary School offers a range of adult education that supports parents not only with functioning day to day of a family, but also supporting parents with children's home work or returning to work.</li> <li>My Plan: Children may be placed on a My Plan to target their academic or social and emotional needs. These SMART targets are created by the class teacher who knows the child best, with support from the Inclusion team where needed. It will allow provision to be focused on the child's needs for a 6 week period, reviewing the targeted support at the end of the term. These plans will be shared with the parents/carers termly.</li> </ul>	<ul> <li>Speech and Language Therapist: At an early age some children may need extra support from a Speech and Language therapist (SALT). The school and parents can make a referral to the SALT service if there are concerns around the children's Communication, Interaction or pronunciation.</li> <li>Gloucestershire Children's Safeguarding Board advice line: This is where schools and members of the community can ring to receive advice around the safe guarding and welfare of children and Young People. They help residents in the local community stay in their current homes or explore alternative housing arrangements. If the school suspects that CSE is happening, a screening tool can be used. Clear information and strategy concerning a CSE cases can be found at www.gscb.org.uk.
